# 1. Course Description

Although this course is primarily about Marriage and Family Therapy, the themes and concepts it explores are relevant for anyone who works with families (e.g., youth workers, pastors, etc.). This course will introduce students to selected theories of marital and family therapy and key intervention methods related to each theoretical orientation. These therapeutic models are examined in terms of their theoretical tenets, views of family functioning and dysfunction, methods of assessment, therapeutic goals, treatment process & techniques, role of the counsellor/therapist and evaluation.

**Doctor of Practical Theology (DPT):** DPT students should refer to the Advanced Elective Template in preparing their learning objectives for this course.

**Research Degree (MA, PhD)** students who enroll in this course are expected to participate in class discussions. Research degree students will complete a major research assignment that integrates the practice of spiritual care with the focus of their research program and/or their vocational goals.

#### 2. Course Format

This course will be delivered using both in-person and via livestream. Reading material is assigned for all sessions. Students are expected to participate in class discussions and to incorporate the class readings and lectures when discussing case studies.

In addition to the scheduled weekly classes, two additional 90 min. seminars will be scheduled for DPT / MA / PhD students for input, dialogue, and collaboration related to their research projects. These will be scheduled with the group. A draft presentation/outline of their paper will be shared with the group for feedback and revision before final submission.

#### 3. Course Objectives

#### 3.1. Knowing

- To understand systemic thinking as it applies to marital and family relations.
- To envision strategies for responding to the challenges of marital and family life.
- To be able to reflect on marital and family life using at least two different perspectives.

- To know when and how to make a referral to a qualified counsellor or therapist.

# 7.1. Participation (Knowing, Being, Doing).

Class sessions will include a mixture of lecture, discussion and case reflection. The participation grade will be assessed on the basis of the student's engagement with class activities as well as the student's ability to respect others in their interactions, to demonstrate familiarity with the readings and texts, and apply the course material in specific situations.

# 7.2. Critical Book Review (DPT, MA & PhD students)

due on March 5, 2024

Students will submit a Critical Book Review (4000 words) of the text by Balswick et al. Students are expected to devote no less than 65% of their paper to analysis of and critical reflection on the outline and structure, the authors' foundational assumptions, and/or the authors' engagement of key themes.

**NOTE**: This assignment is to be submitted via Avenue to Learn.

#### 7.3. Integrative Research

DPT, MA, & PhD degree students will focus their research on a topic that integrates themes related to the theory and practice of working with couples and families in either a ministry or counselling setting and/or the theology of marriage and family.

To facilitate student success, DPT, MA, & PhD students will complete two assignments.

The final form of these research assignments may take the form of a publishable paper, a conference presentation, a course syllabus, a multi-week training program for volunteers, etc.

#### **Learning Objectives:**

- To develop the student's skills in research through reading the research, counselling and theological literature on a specific topic.
- To analyze research findings critically.
- To determine the applicability of research findings to particular clinical or ministry situations.
- To integrate knowledge of research methods and practices with the student's counselling practice or practice of ministry.

#### 7.3.1. Literature Review (DPT, MA & PhD students)

due on Feb 13, 2024

Students will submit an integrative literature review (5000 words) based on academic texts they have read on their chosen topic. Students are expected to read at least 3000 pages of text that includes <u>no</u> fewer than 20 relevant academic (i.e., peer-reviewed) articles.

#### 7.3.2. Integrative Project (DPT, MA & PhD students)

due on Mar 26, 2024

Students will submit a final project (e.g., design a course or lay training program, analytical essay) on a topic of their choice. Although the written form of this project will vary depending on the focus and intent of the project, all submissions are expected to meet the following criteria.

- The written submission is to be 10,000 words (40 pages) in length; inclusive of footnotes and bibliography.
- The written submission will demonstrate a working knowledge of the field.
- The written submission will exhibit a high level of critical thinking and academic writing.
- Students who elect to develop either a training program or a course syllabus will identify the purpose or intent of the course or training program as well as the purpose of the individual components within the project.
- Students who elect to develop either a training program or a course syllabus will include within their
  final project a written background paper (20 pp.) that describes, examines, critiques, etc. a body of
  scholarship related to one key topic that is included in the course or program. The intent of this
  expectation is that the student will demonstrate their knowledge of the topic, their ability to work
  with the source material, and their ability to communicate their knowledge.
- Students who elect to develop either a training program or a course syllabus will include an outline of the entire program or course schedule as an appendix to the paper.
