COURSE SYLLABUS

1. COURSE DESCRIPTION

This course will seek a broad understanding of healthy human development over the life span, as it relates to counselling and ministry, integrating theological perspectives on the nature of man, maturity, and our goals in the “curing of souls”. The course will survey psychological theories of healthy human development including psychodynamic, cognitive, behavioral, interpersonal, moral, and social systems paradigms. In all phases of life, we will see the importance of the relational context of growth and change. After considering different approaches to integrating theological and secular views, we will explore how the normal issues of different stages over the life span influence the formation and development of faith. Student assignments will include applying the general theories to specific populations and circumstances, critiquing the theories presented, considering the implications of a developmental perspective for counselling and other areas of ministry, and reflecting on the significance of developmental theories in understanding our own psychological and theological formation and maturity.

MS 5XK5 for MA, and MS 6XK6 for DPT, and PHD - ADVANCED RESEARCH STUDENTS: Students have assignment requirements that involve more reading and more comprehensive or in-depth written assignments (see below). The instructor will meet with advanced students once or twice per semester to discuss appropriate focus for their proposal, approve the bibliography for their papers, and will be expected to accrue some teaching experience in assisting with in-class activities and giving one short presentation within the course (see Assignments listed below).

2. COURSE FORMAT

This online course is offered as an in person, on campus class which is live-streamed for distance learners, scheduled once a week, to allow maximum time for direct interaction with the instructor, as well as interaction with other students. Course objectives will also be met through personal reflection, reading and written assignments, and other asynchronous (on your own time) online activities, including watching pre-recorded material, other videos, and possibly online discussions with classmates. Class sessions will include didactic instruction, case studies, and other experiential activities such as group breakout discussions and analyses. Assignments are formulated to master the content of the relational developmental theory reviewed, and then be able to apply this content to actual contexts in ministry.

3. LEARNING OBJECTIVES

Students should attend to the learning objectives for their specialization. Through required and optional reading, lectures, class discussion and exercises, and the completion of assignments, the student should fulfill the following course objectives:

- To apply developmental perspectives in designing ministry strategies in one's area of ministry practice
- Advanced Students: To practice skills in facilitating other students' learning through discussions interaction and class teaching.

5. INSTRUCTOR

Biography: Cathryn Harris, Ph.D. C.Psych. is an Affiliate Professor at McMaster Divinity College. For 35 years, and currently fulltime, she has provided psychotherapy and psychological assessments to individuals, couples, families, children and adolescents in outpatient private practice. She has also worked in inpatient and day treatment programs, and provided consultation to pastors, teachers, and business professionals on individual and organizational issues. She has been continuously involved in the training and supervision of Christian mental health professionals for over 30 years, beginning as Adjunct Professor at Rosemead School of Psychology and at Fuller Graduate Seminary for a short while, and for the longest time as Clinical Supervisor for a Christian counselling ministry that placed counselling interns in churches throughout Southern California. It has also been her privilege on a few occasions to provide counselling skills training specifically to Pastors, and enjoys being able to do more of this at MDC. Dr. Harris has been married for over 30 years to another psychologist, and has one adult daughter who has managed to survive that experience.

6. COURSE REQUIREMENTS

A. Class Participation and Self-Reflection - 20% of grade

- i. **Attendance, and participation** in class lectures and **online asynchronous activities** as assigned. Asynchronous activities, such as watching videos online, are crucial to the course content, and replace the 4 hours of lecture time lost during Thanksgiving and Hybrid weeks (see Schedule and Modules on A2L for each week).
- ii. **Reflection Papers:** For each reading assignment, submit approximately 2 pages (double spaced), interacting with either Balswick et al or Cloud et al on a personal level, at the level of disclosure that feels comfortable to you. The purpose of these brief papers is to accomplish the “being” goals by identifying and discussing how the material illuminates developmental factors in your life, or the life of someone close to you, both negative and positive, and how these may have shaped your personality, relationships, and/or faith journey. See the specific questions for each week.
- iii. **Advanced Students:** Your participation grade will also include assisting and facilitating class and online discussions, as assigned according to the needs of the class, and making a 20 minute presentation to the class based on the research of your midterm and/or final paper where it fits into a corresponding unit for the class. The latter will be refined in discussion with the professor.

B. Major Assignments:

ASSIGNMENTS For ALL SPECIALIZATION STUDENTS (MDiv and MTS)

- i. **Midterm Paper: Literature Review** - 40% of grade;
DUE OCTOBER 31st

Include relevant chapters from the course texts, at least one academic monograph (i.e., book) related to this topic, and no fewer than 7 relevant academic (i.e., peer-reviewed) articles drawn from the psychology, social sciences, counselling, pastoral counselling or pastoral care literature.

Paper length: 12-15 pages, double spaced, not including references.

Assignment Description:

A literature review focused on a topic of interest as it applies to individuals and/or families within a specific developmental stage as pertinent to your ministry. The paper must discuss normal human development and/or maturity in this developmental stage as related to the topic or issue. This literature review will form the basis for your final paper, which will be applying your research to your area of ministry and/or specialization. You will need to integrate the relevant themes and

conclusions drawn from the literature (don't just summarize articles or books). See Dr. Mutters's paper under "Content" on A2L as guide to how to write a literature review.

A. Choose a developmental period/Phase of Life:

Early Childhood (0-5 yrs), Middle Childhood (6 to 9yrs), Late Childhood/ Pre Adolescence (10-12yrs), Adolescence (13-18yrs), Early Adulthood (19 to 30yo), Middle Adulthood (30 to 60), Later Adulthood (60+)

B. Choose:

1. Summary and overview of the major milestones and developments of your chosen period. This is your opportunity to become the "expert" on this period. Include the cognitive, emotional, physical, gender/ sexual and social/relational development layers of development (think of it as a "quick reference manual" for this period). Include consideration of relevant issues for this period: for example, What are the questions or issues currently being researched or debated in this period of development? Are these developmental milestones and/or tasks universal, or is their normative variation in their trajectory or expression? How does the achievement of these tasks/milestones potentially influence those of the next period of development?

AND/OR

2. Narrow your topic by choosing one or a combination of the following parameters: Based on current literature, you will discuss how these parameters effect an individual's or family's development (behavioural, biological, cognitive, emotional, gender, moral, sexual, social, and/or spiritual). Make sure that you demonstrate how the issue relates to the predominant cultural view on human development and/or maturity (egs. what typical or "normative" needs or milestones does this issue interrupt or distort? Or how does development look different in this population or context?)

- Crisis issue: Explore a specific aspect of human experience (e.g., bereavement, family violence, illness & disability, immigration, learning disorders, separation, divorce & remarriage)
- Specific Population: cultural or ethnic community,
- Specific Setting or situation: school, foster care, adoptive family, military family/deployment, missions

ii. *Final Paper: Application of Literature Review* - 40% of grade:

DUE DECEMBER 5th

It is expected that you will build on the knowledge gained from the course, and demonstrate how you would apply the insights gained from your *Literature Review* assignment within a ministry context or in the work of counselling and spiritual care.

Paper Length: 12-15 pages, double spaced, not including references.

For Church and Culture (CC) and Christian World View (CW) Specializations

You will draw on the sources used in the first assignment, and you should employ *at least 5* additional source materials to support your view and your plan, for example, sources on ministry applications and strategies.

Developmental Theory and Research applied to a Ministry Application: Discuss how you would apply the conclusions and themes of your literature review in the context of your ministry, particularly what you would do based on your research to encourage greater psychological and/or spiritual maturity and health in your community. Describe the demographics, culture, history, goals, and challenges of your ministry context as it applies to your topic. Then discuss, what are the specific implications of the literature review for your work? How would these developmental factors influence faith development and spiritual maturity? How does this research inform ministry strategies? What specific ministry strategies would you employ for this population in this context? Give the rationale and goals for these strategies and activities from this developmental perspective.

For Counselling and Spiritual Care (CS) Specialization Students:

Include *at least 5* relevant peer-reviewed articles, additional to your original literature research paper which focus on therapeutic strategies.

Developmental Theory and Research applied to Counselling/Pastoral Care: Building on your literature review for your midterm, this paper will outline specifically how you would apply those concepts therapeutically in counseling or caring for persons in your ministry context. Develop and describe an individual, family, or group case example, either hypothetical and/or drawing from personal or ministry experience (taking care to disguise all potentially identifying elements) (this can be single spaced and a smaller font to save space for discussion). Use your chosen developmental lens and research to assess the individual, family, or group in your example, and outline the counseling or other intervention strategies you would use based on your research to help them towards greater spiritual and/or psychological maturity.

ASSIGNMENTS FOR ADVANCED STUDENTS (MA Research, PhD, DPT):

i. **Annotated Bibliography – 15%**
DUE Oct 24th

Your readings should be organized around the chosen topics for your two papers (see below). It is expected that DPT students (5 unit course) complete a **total** of 4,000 pages of reading for this course, and MA/PhD students (6 unit course) complete a **total** of 6,000 pages of reading for this course. The total reading

includes the required reading texts and articles above.

Your additional readings should include academic monographs (books) and relevant academic articles (i.e., peer-reviewed, book chapters, journal articles – NOT websites). Consult the bibliographical resources posted on A2L for additional recommended books and articles, as well as your own research from secular professional journals and, in the area of integration, from the following journals: *Journal of Christianity and Psychology*, *Journal of Psychology and Theology*, *Journal of Pastoral Care*, *Pastoral Psychology*, *Journal of Religion and Health*, *Journal of Pastoral Theology*.

The relevant chapters of your textbooks, plus your additional selected readings will be summarized as an *annotated bibliography* in preparation for writing your two papers (see Dr. Mutter's paper on how to do an annotated bibliography, uploaded on A2L). Summarize each source according to its relevance to your papers in one paragraph, approximately 50-75 words each (may be as long as 100 words for books). This should be submitted to the professor for review, comments, and suggestions prior to writing your papers.

Your annotated bibliography should be organized in two parts:

- 1) **Human Development:** References pertaining to the Developmental Theory of your choice for the first Literature Review below. **A minimum of 10 references.**
- 2) **Integration of Psychology and Theology:** References specifically on systems of integration and on the relationship of psychological development to spiritual maturity. Relevant sources are listed in the bibliography on A2L, or from your additional course texts, or can be obtained from the instructor. Consultation with the professor is appropriate to refine the focus of your paper consistent with your research. **A minimum of 20 references.**

**iii. Midterm Paper: Literature Review - 30% of grade:
DUE NOVEMBER 7th**

It is expected that students will read at least 4000 pages of text in this course, including the assigned textbooks, and additional sources related to their topic of choice that includes academic monographs (books) and no fewer than 20 relevant academic articles (i.e., peer-reviewed) or chapters of books.

Paper Length: 24 to 30 pages, double spaced, not including references.

Assignment Description:

A literature review that explores in depth a particular developmental theory and its implications across the life span.

Identify and evaluate the philosophical assumptions, values, understanding of development, key themes, stages of development and supporting research related to a specific psychological development theory (e.g., Attachment Theory, Erikson,

Fowler, Kohlberg, Objects-Relations Theory, Piaget, etcetera). Include current developments and trends in research supporting, challenging, or modifying the original historical theory.

iv. ***Final Paper: Application of Literature Review*** - 35% of grade;
DUE DECEMBER 5th

Integrative Theological Analysis: Use the text by Entwistle, and other theological and integrative articles, to reflect on the assumptions, insights, and values of the specific developmental theory you chose to explore in depth for your midterm, and discuss how it applies to an integrated view of development, spiritual formation, Christian ministry and/or worldview. It is expected that the student will not merely draw on the sources used in the first assignment but will read at least another 1000 pages of source material additional to that included in your mid term paper, a minimum of 20 references, and draw on systems of integration sources, integrative, and theological articles (see above).

Paper Length: 30-35 pages, double spaced, not including references.

A. Consider one or more of the following questions, and discuss your rationale:

How can this developmental theory be complimentary to or integrated with Christian thought and ministry and how? How can it lend insight into a theme or character in Scripture? How can it contribute to our conceptualization of spiritual formation or Christian maturity?

B. Also discuss: If complementary and able to be integrated, what integration approach are you using in your analysis? Or if not, why not, and based on what integration approach are you forming your conclusion?

C. Conclusion: What is the integrated developmental perspective on your topic that you arrive at based on this analysis?

**** You must support your view, citing other sources, and not just give your own opinion, and you must identify which system of integration you are using.** Consider Scriptural and other pastoral and theological sources to support your discussion.

7. COURSE ADMINISTRATION
